We would also like to bring to your kind notice the following issues faced by the school regarding transport of vehicles in front of the school during the arrival and departure of students.

1. The school timing is from 8.00 a.m to 2.10 p.m and the vehicles start dropping students from 7.15 a.m onwards in the morning. A traffic person is on duty in the morning and afternoon. But due to more number of vehicles there is risk of students being hit. The traffic Police was hit by a vehicle and another incident happened with a student leading to minor injuries.
2. The parents are bringing their vehicles directly in front of the school gate and not heeding to the instructions of Police on duty. The vehicles are also found be moving with high speed.

2. To provide speed breakers in the road before and after the main gate of the school to slow down the vehicles moving on the road.
3. Provide one more Traffic Police on duty in the morning and afternoon (7:15 a.m to 8:00 a.m and 1:45 p.m to 2:30 p.m).

There is a collective request from the parents to inform the authorities about the danger to the lives of small kids. It would be highly appreciated if your good self could take some steps in this regard at the earliest to prevent any unfortunate incident.
